23rd ANNUAL HIGH SCHOOL ART SHOW 2026 PROCEDURES**

No entry fee required. Open to all 9th – 12th grade students attending school in Bosque County as well as students from Hamilton, Hico, McGregor, Whitney High Schools, and Home Schools.

Media Categories: 1. Watercolor/Tempera; 2. Oil/Acrylic; 3. Pastel; 4. Drawing-Pencil/Ink/Charcoal (color and graphite); 5. Mixed Media.* [*Mixed Media is defined as including one or more of the other 4 categories. For example, colored pencil and watercolor or ink and acrylic.]

We accept only original art which does NOT include computer generated or photograph-altered pieces. No previously submitted pieces accepted. Any piece that includes other materials like wood or metal or paper-mâché will be considered craft and not acceptable for this competition.

AWARDS:** Best in Show \$500

Each Media Category: First Place \$100; Second Place \$75; Third Place \$50; and Honorable Mention Ribbons.

**Please note that the judge has complete discretion in selecting the award winners and is not required to award all prizes in each Media Category.

This year's judge will be Lloyd Voges, a local artist and resident of Bosque County. Lloyd painted intermittently since childhood without formal training until 2002. In 2002 Lloyd became a student of Richard Skurla, owner of the Silver Maple Gallery & School, Lloyd studied with Richard and other artists for the next nine years. Since 2009 Lloyd directed his focus full time to his art in a studio on his and Teresa's ranch. His compositions have been in several juried shows throughout Texas and the USA, in which he has placed Best in Show, first, second, third, Publishers Choice, honorable mention, artists and people's choice awards, and Best Depiction of Bosque County. Lloyd served as a juror for the Region XII Visual Arts Scholastic Event Invitational for the Central Texas area for 10 years, as well as a judge for the Bosque Art Club in Clifton. Lloyd was selected into the Western Artists of America in 2011, in 2013 he became a member of the Western Associates, and in 2019 was selected to join the International Guild of Realism as one of their new members. 2021 Lloyd became a signature member of The American Plains Artists, he is also an emeritus member of Western Artists Roundup.

Overall size, not including matting, may not exceed 24" x 36". **All pieces MUST be signed in the lower left or right corner on the front.** Every piece MUST be framed and/or matted, and the hanging mechanism must be able to hold the piece's weight. In the past we have experienced extremely poor hanging methods and capabilities. Art hanging has failed and ended up on the floor of the gallery; the Art Council is not responsible for any damages to the art due to failed hanging mechanisms. If framed with glass, a wire hanger MUST be securely attached and suitable for its weight.

More than one work may be submitted. However, due to space limitations and entries received, the Art Council will determine the number of pieces each student is allowed.

Each submission MUST be listed and titled on a separate entry form. The entry form must then be SECURELY attached to the back of the art piece. If work is to be sold, the price must be on the entry form. Work will be considered "Not for Sale" unless priced on the entry form.

Submissions MUST be delivered to the Bosque Arts Center (BAC), located at 215 S. College Hill Dr. in Clifton, between February 23-27. The BAC Hours of operation are 9am - 5pm, Monday through Friday.

All artists and their family, friends and teachers are invited to a **reception at the Bosque Arts Center, on Saturday, March 7th, from 2 p.m. to 3 p.m.** The awards ceremony will begin at 2:15 p.m. A random drawing for a \$50 gift certificate for art supplies will also be presented; attendance is required at the reception. The Show runs for public viewing from March 9 to March 20, 2026. Unsold work must be picked up the following week, March 23-27. Sold artwork can be picked up by the purchaser at the Bosque Arts Center that same week.
