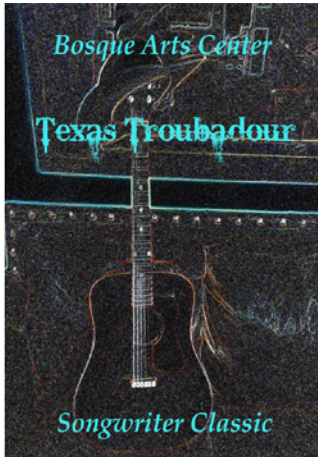

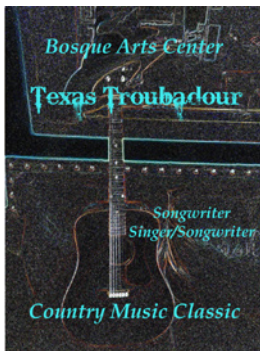

How It works: Entry and Judging Process

- **Entries Open May 20 and close August 20, 2024.**
Entries received after 11:59PM on 8/20/2024 will be rejected.

- **SONG OF THE YEAR AWARD only** – Upload songs in mp3 format on website or mail a CD to address above. **Mp3s cannot be larger than 6 MB.**
The songwriter does not have to be the vocalist for this category.

- **TEXAS TROUBADOUR AWARD** - To enter the live performance event, you **MUST** submit a minimum of 3 songs in the Song of the Year category. Upload the songs in mp3 format and enter a hyperlink to a performance video (video performances must be one of the songs submitted by mp3). If you are among the singer/songwriters invited to perform at the live event finals, you will be required to choose from the songs entered in the Song of the Year category for performance at the event.
Performance DVDs may also be submitted by mail to the address above.

- *The website will open for entries beginning on May 20, 2024*
The deadline TO RECEIVE entries is August 20, 2024

(Entries received online or postmarked after 11:59PM on August 20, 2024, will not be presented for judging.)
Letters advising of invitation to perform at the live event will be mailed/e-mailed by September 30, 2024.

- *A jury composed of experienced songwriters and other personnel from the music industry will review each entry and select the Song of the Year category finalists as well as the 5-7 finalists to be invited to perform at the live event.*
Final judging will be completed and announced at the live performance event.

- *The Song of the Year Award winner will be selected by the finals judge prior to Texas Troubadour live performance event. The winner will be announced at the live event. If the winning songwriter is not present, the winner will be announced on the BAC website and Texas Troubadour Facebook page, and notification will be made by telephone or e-mail within the week after the live event on October 26, 2024.*

1. A completed entry form must accompany online or mailed entries.
2. Each song submitted **MUST** be entrant's original work. SONGS MAY NOT EXCEED (4) FOUR MINUTES IN LENGTH. Songs may have multiple co-writers, but **PLEASE** designate (1) one name **ONLY** on the Entry form.
3. Mailed entries: Please place multiple song entries on one CD. Submit the CD in plastic CD case, regular or thin-line. Label CD and the CD case with entrant's name, e-mail, address and telephone number with black marker. **BE SURE TO LABEL BOTH THE CASE AND THE CD**. Include a track listing of songs in correct order. If entering Texas Troubadour category, submit a DVD or hyperlink of a live performance of one of the songs entered.
4. Mailed entries **MUST** include completed entry form with your name, e-mail, address, telephone number and the titles of all songs submitted. Entries **MUST** include a lyric sheet for each song with the title at the top. Entries with sheet music or charts only instead of required lyrics sheets and appropriate music media will be **REJECTED**. Lyrics for mail-in entries may also be submitted in digital form, on CD, flash drive, etc.
5. Make online song entries by mp3 uploads at the following address:

Enter song title and copy and paste or type complete lyrics into text box provided. **Do NOT include songwriter's name in lyrics text box**. If entering Texas Troubadour category, after uploading songs, copy and paste or type a hyperlink of a live performance of one of the songs entered in the box provided. (*If mailing a DVD of the performance, type www.BosqueArtsCenter.org in the blank*).
6. All entries must be original songs written or co-written by the entrant; song does not have to be performed by the songwriter for non-performance category. **The entry cannot infringe any copyrights or any other rights of any third parties**. Entrant shall, by entering, indemnify and hold Bosque Arts Center harmless from and against any claims inconsistent with the foregoing.
7. Entrant retains all ownership rights to all submitted songs. Bosque Arts Center (BAC) will not have any ownership rights to any songs submitted.
*By submitting songs the entrant is granting the Bosque Arts Center permission to use songs for compilation CDs, DVDs, and/or future event promotion, without compensation.
****YOU MAY REVOKE THE CONSENT FOR THE COMPILATION CDs/DVDs IN WRITING AT ANY TIME. THE BAC WILL RETAIN THE RIGHT TO USE LIVE PERFORMANCES FOR EVENT PROMOTION.****
8. Entry fees are NOT refundable. TTSC does not give feedback or critiques.
9. Contestants do not have to be Texas residents to enter.
10. **PREVIOUS YEARS' WINNERS** are eligible to compete but may not enter songs that won in a prior year. For example, previous Song of the Year winners may not re-enter the winning song. Texas Troubadour Award (Singer/Songwriter) winners may not re-enter the 3 songs performed at the live event.
11. A CAPPELLA, INSTRUMENTAL, and POETRY entries will NOT be accepted. Songs must have vocals and some sort of accompanying musical instrumentation.

\$15.00 per online song entry; \$20.00 per song entry by CD

One-time Entry Fee of \$15.00 for Texas Troubadour Award consideration*

**Contestants for TTA must enter at least 3 songs in Song of Year category.*

- *All entries MUST be submitted with a completed entry form online or by mail.*
- *Lyrics MUST be submitted with all entries. MAILED ENTRIES: Please provide a copy of each lyric sheet with song titles.*

ONLINE ENTRIES: Enter song title and lyrics only. **Do NOT type your name within the lyric text box.**

- *Entrant MUST be the Singer AND Songwriter of all songs to be considered for the Texas Troubadour Award.*
- *Entries for Song of the Year Award do not have to be sung by the songwriter.*
 - *All entries must have musical accompaniment.*
- *Entries will be judged on lyrics and music alone. Recording quality will not be a consideration; therefore, studio recordings are not required.*

Contestants may create mp3s, CDs, or video using any available technology.
- **Entries for LIVE performance competition for Texas Troubadour Award must submit at least 3 songs in the Song of the Year category in addition to a video of a live performance of one of the songs entered for Song of the Year. Video may be submitted by hyperlink or mailed DVD.*
- **IMPORTANT!!!** The performance video allows the judges to evaluate stage presence.

Texas Troubadour Songwriter Classic Live Event - October 26, 2024

If you are invited to participate in the Texas Troubadour live event:

- **You will be required to perform songs entered in the current year's competition (therefore screened by the judges). You may enter as many songs as you choose for Song of the Year to provide yourself a larger selection from which to choose for live performance.**
 - **You will be notified in advance of the number of songs you will perform.**
 - **You must be prepared to travel to Clifton, Texas, for the event on October 26, 2024.**
 - **At the live event, you must accompany yourself with one (1) instrument only for all songs performed.**
- In addition, you may have ONE (1) backing musician (with 1 instrument only). NO backing vocals are allowed.**
NO A CAPPELLA ENTRIES are permitted • Absolutely NO BACKING BANDS are permitted.
